RESOLUTION NO. 2026-05 ADOPTING THIRD AMENDMENT TO THE REVISED INTERGOVERNMENTAL AGREEMENT BETWEEN THE COUNTY AND MUNICIPALITIES OF SCOTT COUNTY FOR THE WASTE COMMISSION OF SCOTT COUNTY

WHEREAS, by intergovernmental agreement (the "Agreement") there has been previously established the Waste Commission for Scott County (the "Commission") to provide municipalities and Scott County with solid waste management services.

WHEREAS, the Agreement was amended by a first amendment adopted by the Commission's governing board (the "Governing Board") on December 13, 1994 and a second amendment adopted by the Governing Board on August 29, 2000.

WHEREAS, the Governing Board has now decided to amend the Agreement in the manner contained within the Third Amendment to the Revised Intergovernmental Agreement Between the County and Municipalities of Scott County for the Waste Commission of Scott County, attached hereto.

WHEREAS, the aforementioned third amendment was submitted to the members of the Commission for review and comment.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BOARD OF THE WASTE COMMISSION OF SCOTT COUNTY, IOWA:

Section 1. That the Third Amendment to the Revised Intergovernmental Agreement Between the County and Municipalities of Scott County for the Waste Commission of Scott County (the "Third Amendment"), including all understandings and alterations contained therein, substantially in the form attached hereto, is hereby authorized and approved in all respects.

Section 2. That the Executive Director is authorized and directed to electronically file the Third Amendment with the Secretary of State within thirty days of its approval, as required by Iowa Code sec. 28E.8.
